
Commissioner Rockensies reported that he performed a mark-out at 106 Hempstead Turnpike. He located the curb box and water service needed.


At the direction of the Board, Commissioner Corino executed the payments.

At the direction of the Board, Commissioner Corino executed the payments.



The Board received a monthly statement from TD Bank gave it to Commissioner Corino for him to reconcile the checkbook.




The Board received a monthly statement from TD Bank gave it to Commissioner Corino for him to reconcile the checkbook.
